## Child Development Associate Competency Standards and Functional Areas (CDA)

The CDA Competency Standards are the national standards used to evaluate a caregiver's performance with children and families during the CDA assessment process. The Competency Standards are divided into six Competency Goals, which are statements of a general purpose or goal for caregiver behavior. The Competency Goals apply to all child care settings.

- 1. To establish and maintain a safe, healthy learning environment
- 2. To advance physical and intellectual competence
- 3. To support social and emotional development and to provide positive guidance
- 4. To establish positive and productive relationships with families
- 5. To ensure a well-run, purposeful program responsive to participant needs
- 6. To maintain a commitment to professionalism

## **Professional Development** - 30 hrs. Training Courses

NYC and NYS Regulations require Family Day Care Providers, Group Family Day Care Providers, Group Family Day Care Assistants, and Center Based Staff to complete a minimum of 30 hours of training every two years that incorporates all nine OCFS content areas (see page 4).

The 30 hours of training can consist of *any* combination of classes as long as the *total* 30 hours has all 9 OCFS content area represented in some fashion.

## **Safety and Security Procedures**

## > CPR & First Aid for Infants and Children

(OCFS: 1, 2, 3, 4; Core: 5, 7 CDA: 1, 2, 6)

This training will prepare all caregivers with the basic knowledge and skills in CPR and First Aid. Participants will learn to recognize an emergency and provide care for infants and children until authorized medical personnel arrive.

Both American Red Cross CPR certification and Infant & Child First Aid certification are valid for 2 years.

## ➤ Health and Safety for Family & Group Family Providers

(OCFS: 2, 3, 5, 6, 7, 8, 9; Core: 5, 7; CDA: 1, 2, 4, 5, 6)

The Health and Safety training series is required for anyone wishing to become registered or licensed as a home-based Family or Group Family Child Care Provider in New York State. The Day Care Council also highly recommends all providers re-take this class every 4 years as part of their 30hour training. The **series** will cover the Office of Children and Family Services (OCFS) training modules such as proper diapering, sanitizing, child care safety, and nutrition.

## > Infectious Disease Control

(OCFS: 2, 3, 7; Core: 5, 7; CDA: 1, 5, 6)

Understand how to prevent, recognize, and manage infectious diseases in child care settings. Participants will learn to apply infection control procedures as per the state and national guidelines for hand-washing, diaper-changing, and many other health issues that are exclusive to early care.

## Mandated Reporter/Child Abuse and Maltreatment

(OCFS: 6, 8, 9; Core: 5; CDA: 1, 3, 5, 6)

The purpose of this training is to provide the participant with the knowledge to make an informed decision about whether a situation involves child abuse or maltreatment, what the reporting obligation is, and how to go about making such a report. The objectives of this training are to help:

- Report child abuse or maltreatment/neglect to the New York State Central Register (SCR)
- > Evaluate situations to determine whether there is reasonable cause to suspect child abuse or maltreatment/neglect
- ➤ Identify the physical and behavioral indicators commonly associated with child abuse and maltreatment/neglect
- > Understand the legal framework for the New York State Child Protective System

Participants will receive a formal Certificate of Completion authorized by the **Center for Development of Human Services** and the **New York State Office of Children and Family Services**.

## ➤ Medication Administration Training (MAT)

This training is required for child care providers to administer medication to children in their programs. Participants will learn and practice how to administer medications properly and how to record when medications are given. Please have your program license or permit number with you.

## > Sexual Harassment in the Workplace

(OCFS: 3, 7; Core: 6, 7; CDA: 5, 6)

NYS has mandated that annual sexual harassment training be implemented for all employees as part of a basic human resources package. This 3-hour workshop will help employees provide and maintain a happy and safe work environment free form hostility and discomfort. The session will be interactive, include remedies available to victims, inform participants of pertinent laws, provide definitions and examples of harassment, and provide information addressing conduct and additional responsibilities of employers.

Any licensed/regulated child care setting that chooses to administer medications to children must have staff with the appropriate training, including MAT (Medication Administration Training). Each of these child care settings must also have a Health Care Plan approved by a Health Care Consultant (MD, RN, NP or PA). #### CHILD CARE PROVIDER SPECIALISTS
