Child Development Associate Competency Standards and Functional Areas (CDA)

The CDA Competency Standards are the national standards used to evaluate a caregiver's performance with children and families during the CDA assessment process. The Competency Standards are divided into six Competency Goals, which are statements of a general purpose or goal for caregiver behavior. The Competency Goals apply to all child care settings.

1. To establish and maintain a safe, healthy learning environment
2. To advance physical and intellectual competence
3. To support social and emotional development and to provide positive guidance
4. To establish positive and productive relationships with families
5. To ensure a well-run, purposeful program responsive to participant needs
6. To maintain a commitment to professionalism

Professional Development – 30 hrs. Training Courses

NYC and NYS Regulations require Family Child Care Providers, Group Family Child Care Providers, Group Family Child Care Assistants, and Center Based Staff to complete a minimum of 30 hours of training every two years that incorporates all nine OCFS content areas (see page 4).

The 30 hours of training can consist of *any* combination of classes as long as the *total* 30 hours has all 9 OCFS content area represented in some fashion.

Safety and Security Procedures



➤ Adult and Pediatric CPR & First Aid

(OCFS: 1, 2, 3, 4; Core: 5, 7; CDA: 1, 2, 6)

This training will prepare all caregivers with the basic knowledge and skills in CPR and First Aid. Participants will learn to recognize an emergency and provide care for infants and children until medical personnel arrive.

Both American Red Cross CPR certification and Infant & Child First Aid certification are valid for 2 years.

➤ Health and Safety for Family & Group Family Providers

(OCFS: 1, 2, 3, 4; Core: 5, 7; CDA: 1, 2, 6)

The Health and Safety training series is required for anyone wishing to become registered or licensed as a home-based Family or Group Family Child Care Provider in New York State. The Day Care Council also highly recommends all providers re-take this class every 4 years as part of their 30hour training. The series will cover the Office of Children and Family Services (OCFS) training modules such as proper diapering, sanitizing, child care safety, and nutrition. Grants are available for currently licensed providers through the SUNY EIP Program.

➤ Medication Administration Training (MAT)

(OCFS: 1, 2, 3, 4; Core: 5, 7; CDA: 1, 5, 6)

This training is required for child care providers to administer medication to children in their programs.

Participants will learn and practice how to administer medications properly and how to record when medications are given. Please have your program license or permit number with you.

➤ **Infection Control Procedures**

(OCFS: 2, 3, 7; Core: 5, 7; CDA: 1, 5, 6)

Understand how to prevent, recognize, and manage infectious diseases in child care settings. Participants will learn to apply infection control procedures as per the state and national guidelines for hand-washing, diaper-changing, and many other health issues that are exclusive to early care.

➤ **Allergy Awareness & Elijah's Law**

Sharpen participants' emergency response to medical emergencies and increase their confidence and skills in emergency medication administration.

It evaluates the child care provider's ability to offer an open and exploratory environment, responsive caregiving, and age-appropriate materials and experiences. It can be used as both a self-assessment tool as well as a guided Endorsement process in partnership with an Infant Toddler Specialist.

HEALTH CARE CONSULTANT

The Day Care Council of New York heads efforts to assist child care settings in implementing NY State's Medication Regulations. Any licensed/regulated child care setting that chooses to administer medications to children must have staff with the appropriate training, including MAT (Medication Administration Training). Each of these child care settings must also have a Health Care Plan approved by a Health Care Consultant (MD, RN, NP or PA). To assist with your Health Care Plan and other questions, please contact 212-206-7818 ext. 2120.

TECHNICAL ASSISTANCE

The Child Care Provider Specialists are professionals that can be consulted by telephone and free of charge. In addition, they conduct site visits to child care settings. These are some of the many services that they can help you with: technical assistance, information on quality child care best practices, information on the regulations and requirements of Articles 47, 416 and 417 of the Office of Children and Family Services (OCFS) and Department of Health and Mental Hygiene (DOHMH), and the Environmental Rating Scales (ITERS, ECERS and FCCERS).
