And we will push to ensure that the early childhood workforce receives the compensation they deserve!

About Us



DCCNY is committed to programs and services that promote sound growth and development of children and their families.

The Day Care Council of New York (DCCNY) is a diverse membership organization of publicly and privately funded early childhood education and care and family service providers, consumers, and advocates. DCCNY's mission is to seek support for and assist in the development and operation of quality early childhood education and care services. The organization works with its members to maintain high standards of child development, education, and social supports.

Our Programs & Services

Services for Members

Labor Relations and Mediation Service (LRAS)

Since 1948, DCCNY has worked with NYC and child care providers to ensure that New York's youngest children receive the highest quality early childhood education and care. Today, the Member Services Team continues to provide critical assistance to child care employers with unionized and non-unionized employees to resolve workplace issues, personnel matters, and employee grievances. The team also provides legal representation to DCCNY members in arbitration, human rights complaints, and National Labor Relations Board proceedings. We help organizations create, implement, and maintain legal and administrative structures that promote fair labor and employment practices in high quality early childhood education settings. Members also receive training to ensure that personnel policies, disciplinary actions, and discharges follow the respective collective bargaining agreements, as well as Federal and State labor and employment laws.

Early Childhood Career Ladder (ECCL)

NYC's early childhood education and care system relies on the network of community based organizations and providers that operate programs. Since 2017, DCCNY has administered a financial assistance program founded to address one of the most significant issues facing community based early childhood programs – the lack of certified teachers. The program has successfully helped early childhood education and care professionals advance in their careers and become stronger, more credentialed teachers through supporting their pursuit of additional education and credentialing.

Services for Families

DCCNY provides child care information, referrals, and assistance to more than 3,000 families annually. Our trained Child Care Specialists help families identify licensed child care providers, summer camps, and after-school, Head Start, Pre-K, and Special Needs programs that meet families' specific geographic and financial needs. Child Care Specialists assist in designing personalized child care plans, connect families to additional support services such as special education/early intervention referrals, mental health services, housing support, food security resources, and health insurance, and make necessary referrals to community services.

Services for Providers

NYC Child Care Resource & Referral Consortium (NYC CCR&R), Child Care Business Consultation, Infant Toddler Mental Health Consultation, Infant Toddler Services

Since 1989, DCCNY has provided training and technical assistance to thousands of NYC early care and education providers including family child care programs, child care centers, and school-age programs. Services include: board training; early childhood training; networking events; business and quality improvement grants; health care quality improvement grants; Medicine Administration Training; infant and toddler technical assistance, training and mental health consultation; and individualized technical assistance projects using Environmental Rating Scales (ERS) or other quality-assessment tools.



Family Child Care Network (FCCN) Child and Adult Care Food Program (CACFP)

Since 1993, DCCNY has served as a vital resource for the increasing number of family and group child care providers offering child care in their Southeast Queens homes. The team supports 130 providers that serve approximately 1,500 children from birth to age 12. Providers receive assistance with start-up, licensing, training, and educational and other resources to maintain their businesses and meet state guidelines. In 2020, DCCNY launched a DOE-funded Family Child Care Network (FCCN) which enhances, supports, and strengthens child care, from birth through 3K, and assists in the development of quality child and family services and the implementation of effective operational practices. Our services also enable providers to receive reimbursement for the nutritious meals and snacks served to children in their care. Nutrition workshops focused on implementing menu plans, recordkeeping, and training are offered as technical support. The program contributes to young children's wellness, healthy growth, and development.

New Initiatives

Childcare Assistant Apprenticeship Program (CAAP)

In 2021 DCCNY partnered with Bronx Community College to launch the *Childcare Assistant Apprenticeship Program (CAAP)* which is designed to give community residents the opportunity to work in child care centers in the South Bronx while earning their Child Development Associate (CDA) Credential tuition free at Bronx Community College. Apprentices work under the mentorship of experienced teachers and directors while gaining the education, experience, and credentials needed for several positions within community-based early childhood education programs.

Public Policy

We supported policies and delivered services that strengthened the early childhood workforce, so that all NYC children could access the highest level of care. This year, our efforts were covered in the following outlets:

COVID-19 Response

NYS Budget Victories

In FY 2022, DCCNY was instrumental in securing the following NYS budget victories:

- **\$7 billion**+ over four years to support affordable child care for low-income families in every part of New York State
- The elimination of burdensome requirements that prevent families from accessing child care and increases in child care accessibility that will make approximately half of New York State families eligible for child care assistance
- A **\$343 million** child care stabilization fund that will support teachers, staff, and directors in child care programs
- Increases in State reimbursements for child care



NYC Budget Victories

In FY 2022, DCCNY was instrumental in securing the following NYC budget victories:

- **\$10 million** to provide child care for undocumented families
- \$46 million for wage increases in community-based child care programs and Pre-School Special Education Programs


